Commitments (max 200 words): SLCP commits to investing in data insights and research to drive further sharing of social compliance data with partners. SLCP will work closely with the International Trade Centre and key partners to engage policymakers and governments, ensuring trends and insights are not only shared amongst SLCP signatories, but with regulators. This will enhance their understanding on supply chain issues – particularly for the apparel & textile sector – and open opportunities to drive tailored policy initiatives. The annual SLCP Impact Report, research papers, and factsheets will be published in 2024, and specific engagements will be undertaken to further share the data.

- To publish annual SLCP Impact Reports (latest version May 2024)

- Map upcoming tool developments with regulatory expectations to ensure the data collected is relevant and useful for human rights due diligence implementation and share this with stakeholders
